If you wish Dementia UK to claim Gift Aid on donations collected at your event please follow these three steps:

1. Ensure that guests give a donation amount of their choice. Therefore, please don't put price tags on your cuppas and cakes as we cannot claim Gift Aid on direct proceeds of a sale.
2. Ask your guests to fill in **every column in their own handwriting** and tick to confirm if they want to Gift Aid their donation.
3. Send the completed form to Dementia UK in the Freepost envelope provided in your pack.

We can't claim Gift Aid on donations from raffles, auctions, entry fees, ticket sales and competitions.
